



The Joint Crisis Communication Team must regretfully announce the passing of one Macon County resident with COVID-19. This resident was a male in his 70s. Our team would like to

extend our heartfelt condolences to the family and friends of this person. Please give them the respect and privacy they deserve as they mourn the loss of their loved one.

Today, while the Joint CCT is reporting 34 newly-confirmed cases, please note that the total number of confirmed cases is only increasing by 33. During case investigations, it was determined that one of the cases reported yesterday did not belong in Macon County's case count. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 1,675.
