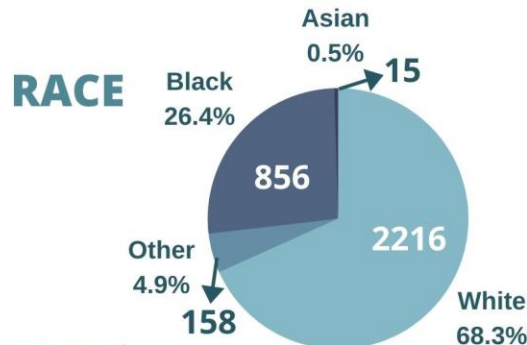
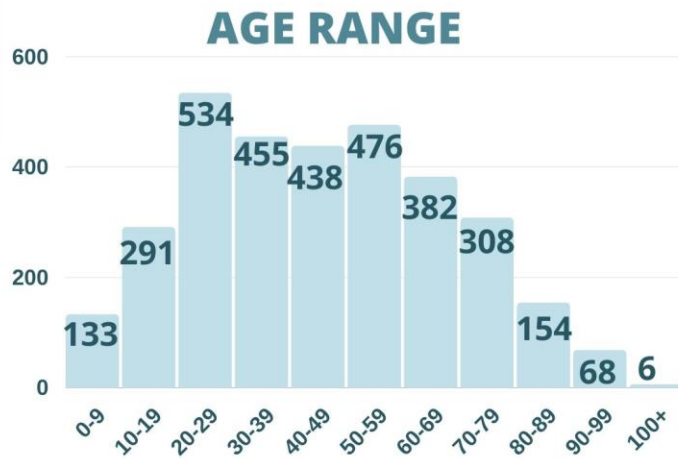
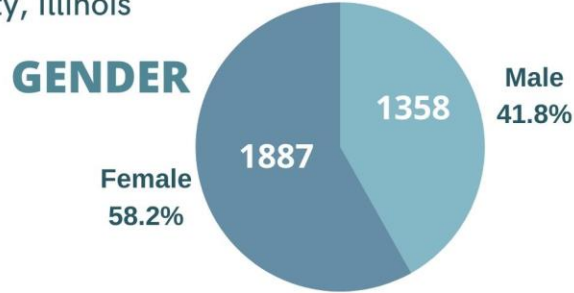

The Joint Crisis Communication Team must regretfully share the news of the passing of another Macon County resident with COVID-19. This resident was a female in her 70s. Our team extends our heartfelt sympathies to the family and friends of this person, and we ask that they are given the respect and privacy they deserve as they mourn this incredible loss.

Today, the Joint CCT is reporting 69 newly-confirmed cases of COVID-19. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 3,245. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.
