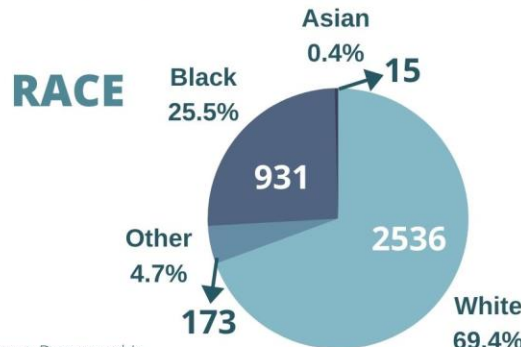
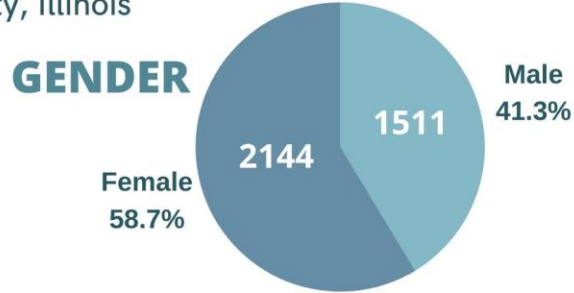

With great sadness, the Joint Crisis Communication Team must share the news of the passing of two Macon County residents with COVID-19. These residents were males, one in his 90s and one in his 50s. Our team extends our sincere condolences to the families and friends of these people, and we ask that they are given the respect and privacy they deserve as they mourn their incredible loss.

Today, the Joint CCT is reporting 76 newly-confirmed cases of COVID-19. Please note that while there are 76 newly-confirmed cases today, it was determined through case investigations that one of the recently-reported cases was a resident of another county and their case was transferred to the appropriate health department. Thus, the total number of cases is 75 more than yesterday. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 3,655. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.
