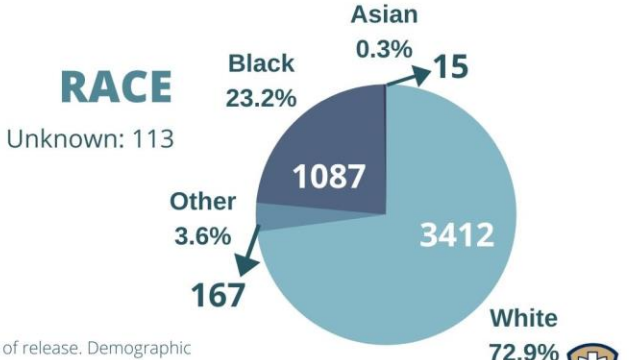
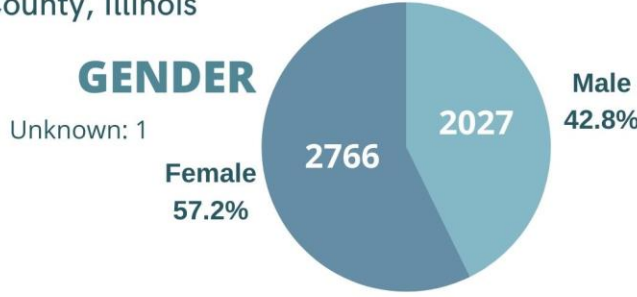

It is with heavy hearts that the Joint Crisis Communication Team must inform you that we have had six additional Macon County residents pass with COVID-19. Four residents were females, one in her 60s, one in her 70s, one in her 80s and one in her 90s. Two residents were males, one in his 70s and one in his 80s. Our team extends our sincere condolences to the families and friends of these people, and we ask that they are given the respect and privacy they deserve as they mourn their incredible loss.

Today, the Joint CCT is reporting 80 newly-confirmed cases of COVID-19. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 4,794. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.
