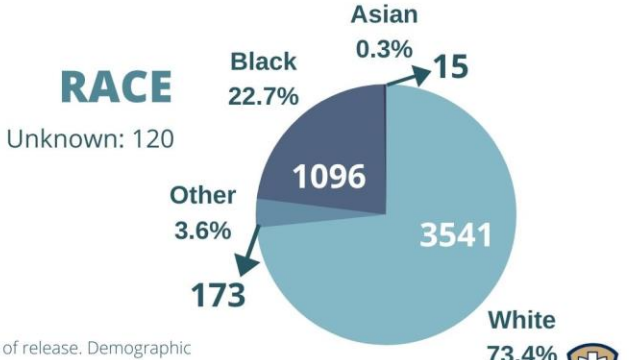
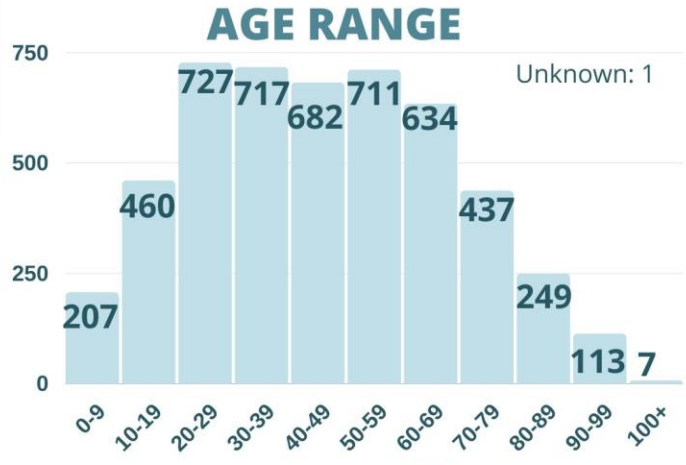
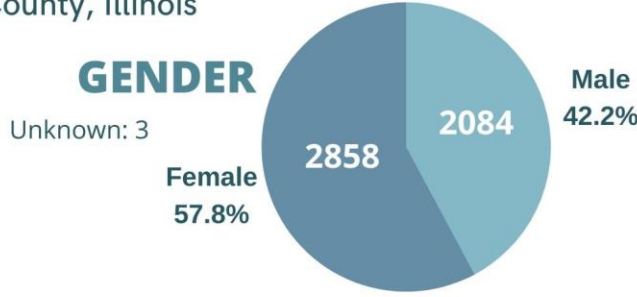

The Joint Crisis Communication Team is saddened to share the news of the passing of another Macon County resident with COVID-19. This resident was a female in her 100s. Our team extends our sincere condolences to the family and friends of this person, and we ask that they are given the respect and privacy they deserve as they mourn their incredible loss.

Today, the Joint CCT is reporting 112 newly-confirmed cases of COVID-19. Please note that while there are 112 newly-confirmed cases today, it was determined through case investigations that one of the recently-reported cases was a resident of another county and their case was transferred to the appropriate health department. Thus, the total number of cases is 111 more than yesterday. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 4,945. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.
