



It is with heavy hearts that the Joint Crisis Communication Team must inform you that we have had one additional Macon County resident pass with COVID-19. This resident was:

- One female in her 90s

Our team extends our sincere condolences to the family and friends of this person, and we ask that they are given the respect and privacy they deserve as they mourn their incredible loss.

Today, the Joint CCT is reporting 98 newly-confirmed cases of COVID-19. Please note that while there are 98 newly-confirmed cases today, it was determined through case investigations that two of the recently-reported cases were residents of other counties and their cases were transferred to the appropriate health departments. Thus, the total number of cases is 96 more than yesterday. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 6,149. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.
