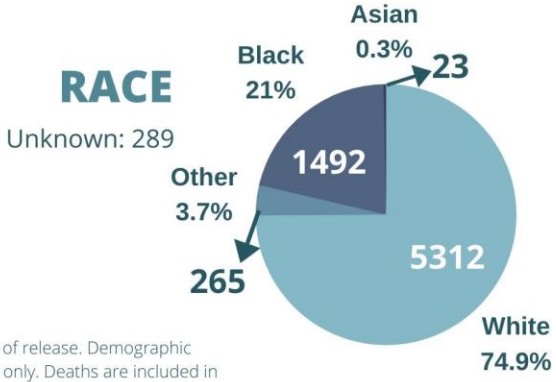
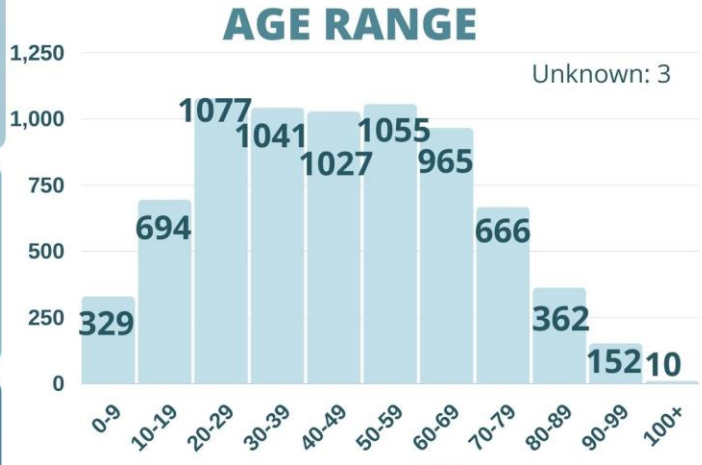
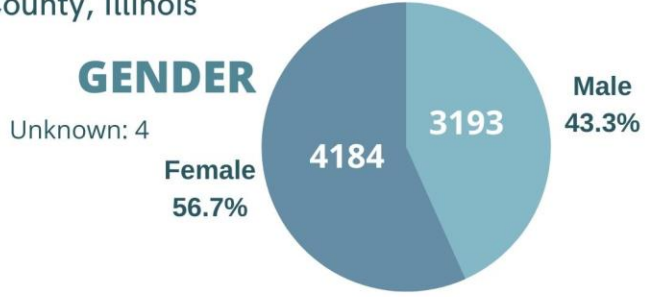

All numbers reflect status at time of release. Demographic information reflects confirmed cases only. Deaths are included in the number of confirmed cases. All numbers displayed are provisional and are subject to change.



Today, the Joint CCT is reporting 49 newly-confirmed cases of COVID-19. Please note that while there are 49 newly-confirmed cases today, it was determined through case investigations that one of the recently-reported cases was a resident of another county and their case was transferred to the appropriate health department. Thus, the total number of cases is 48 more than yesterday. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 7,381. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.
