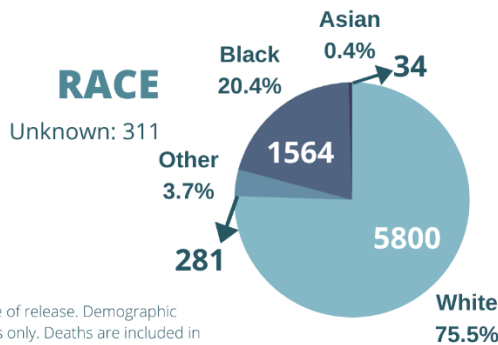
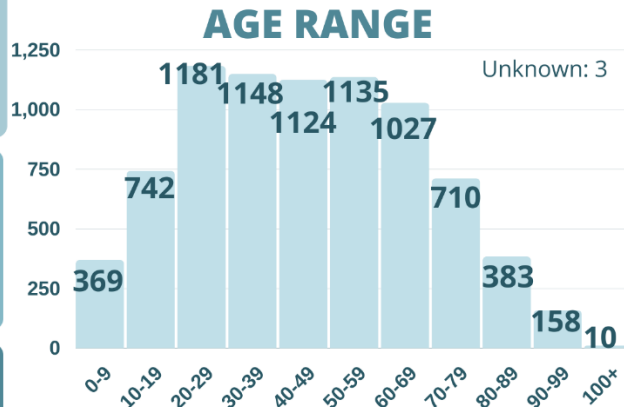
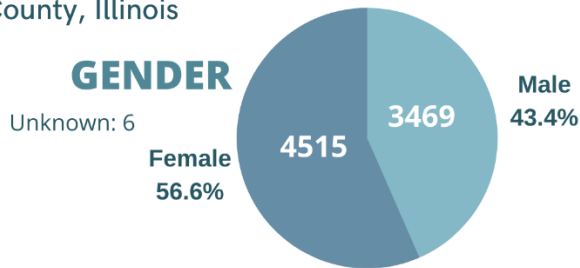

It is with great sadness that we, the Joint Crisis Communication Team, must announce the passing of four Macon County residents with COVID-19. These residents were:

- Two females in their 70s.
- Two males in their 90s.

We ask that you please respect the privacy of their families and friends as they mourn their significant loss.

Today, the Joint CCT is reporting 49 newly-confirmed cases of COVID-19. Please note that while there are 49 newly-confirmed cases today, it was determined through case investigations that one of the recently-reported cases was a resident of another county and their case was transferred to the appropriate health department. Thus, the total number of cases is 48 more than yesterday. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 7,990. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.

Do not show up at a hospital emergency room or doctor's office unless it is a true emergency.

 - 7 days a week, 8:00 a.m.- 4:00 p.m.
 - 12/31/2020: 8 a.m. – noon
 - 1/1/2021: Closed
- Crossing Healthcare: Drive-through testing located at 990 N. Water St.
 - Monday- Friday, 8:00 a.m.- noon (appointments are strongly encouraged, but not required)
