



The Joint Crisis Communication Team is incredibly saddened to announce the passing of one Macon County resident with COVID-19. This resident was a female in her 80s. We ask that you please respect the privacy of the family and friends as they mourn their incredible loss.

Today, the Joint CCT is reporting 89 newly-confirmed cases of COVID-19 since December 31, 2020. On Friday, January 1<sup>st</sup>, there were 52 new cases of COVID-19 and today, January 2<sup>nd</sup> we have 37 new cases. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 8,126. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.

  - 7 days a week, 8:00 a.m.- 4:00 p.m.
  - Closed 1/1/2021
- Crossing Healthcare: Drive-through testing located at 990 N. Water St.
  - Monday- Friday, 8:00 a.m.- noon (appointments are strongly encouraged, but not required)
