**Crisis Communication Team Press Update**

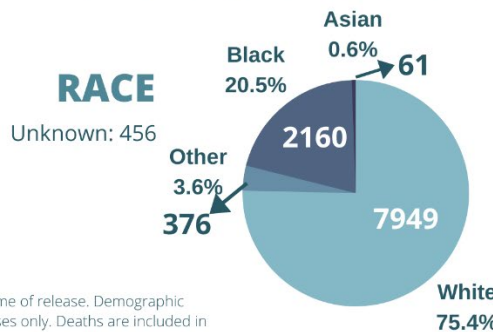
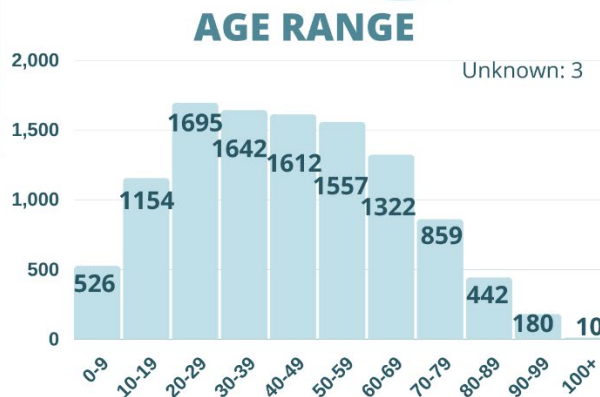
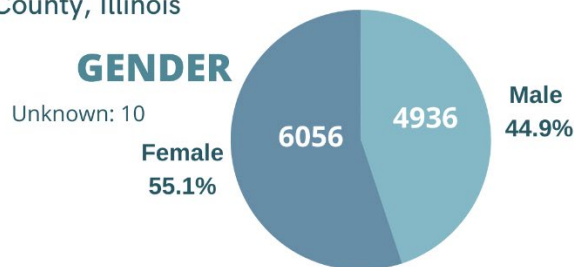

Total Number of Confirmed Cases in Macon County Since Start of Pandemic:

Through case investigations and contact tracing, it was determined that one previously-reported case was a resident of another county and their case was transferred to the appropriate health department. Thus, the total number of cases is 4 more than yesterday's total.
