















Crisis Communication Team Press Update

As of today's release, the Joint Crisis Communication Team (CCT) reports the following numbers:



The Joint Crisis Communication Team is saddened to share the news of the passing of two Macon County residents with COVID-19. One resident was a male in his 50s, and the other resident was a female in her 90s. Our team extends our sincere condolences to the families and friends of these people, and we ask that they are given the respect and privacy they deserve as they mourn their incredible losses.

Today, the Joint CCT is reporting 132 newly-confirmed cases of COVID-19. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 5,603. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.
