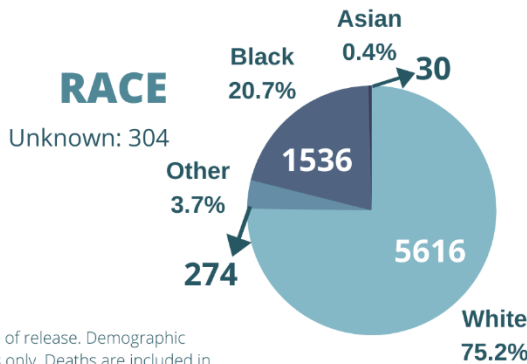
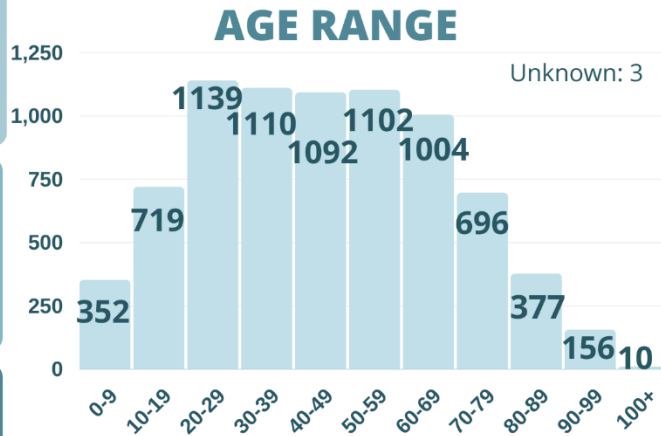
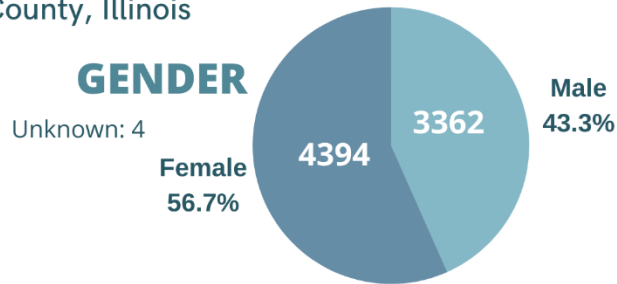

It is with heavy hearts that the Joint Crisis Communication Team must inform you that we have had two additional Macon County residents pass with COVID-19. Both residents were females in their 90s. Our team extends our sincere condolences to the families and friends of these people, and we ask that they are given the respect and privacy they deserve as they mourn their incredible losses.

Today, the Joint CCT is reporting 28 newly-confirmed cases of COVID-19. Therefore, since the start of the pandemic, the total number of confirmed COVID-19 cases in Macon County residents is 7,760. Please acknowledge that every person affected by this pandemic is a human being with family, friends, and a future that is changed by COVID-19. It is up to every single member of this community to do EVERYTHING that they can do prevent the spread of this virus and the consequences associated.

- Crossing Healthcare: Drive-through testing located at 990 N. Water St.
 - Monday- Friday, 8:00 a.m.- noon (appointments are strongly encouraged, but not required)
