Due to the COVID-19 pandemic and the Governor's April 2, 2021, Disaster Declaration, the Governor's Executive Orders (including, but not limited to, EO 2021-06) and section 7 of the Open Meetings Act (as amended by P.A. 101-640), the President of the Board of Health has determined that an in-person meeting is not practical or prudent because of the declared disaster. Therefore, this public meeting will permit but not require attendance by members of the Macon County Board of Health by telepresence. Members of the public are allowed to physically attend, subject to the limitation that no more than 15 people may be allowed to be physically present in the meeting room. In the event that more than 15 people physically attend, preference will be given in the following order: Board of Health members; Health Department staff; members of the press, members of the general public. Anyone not able to physically attend due to occupancy restrictions may listen to/view the meeting contemporaneously via the livestream website stated above.
